### 2. Message from our Patron

The big shift is happening. The World Bank and the European Development Bank will no longer fund coal fired power stations. Stanford University has voted to divest from all fossil fuels in its huge pension fund. Blackrock, the largest investment fund in the world, along with the FTSE stock exchange in London, have launched a special investment vehicle for the discerning - it avoids all fossil fuels. The NZ Anglican Church has voted at synod level to get rid of all its investments in fossil fuels, and, the jewel in the crown, Dunedin City has done the same!

I'm very proud of the role Blueskin has played in the Dunedin decision. Citizens can make a difference. And on the international stage, we've just heard that a huge campaign by GetUp in Australia and Germany with full page ads in the financial papers and flooding face book and twitter, have persuaded Deusche Bank not to fund the devastating blasting of the Great Barrier Reef to allow coal exports. That will have spin off effects on the coal industry trying to raise finance for its port and its mining.

Everything we do to make fossil fuels more unpopular or more difficult to exploit will make energy efficiency and renewable energy easier as the alternative.

It's great to see the Trust with links now right around the country with like-minded organisations, and also with the mainstream. So much has happened in the last year, with major progress on home insulation and solar and food production and low carbon transport, and not least in getting the wind project to the stage of business negotiations.

Well done everyone and I look forward to another year of Blueskin leading the world in sustainability!

# 3. Chairperson's Report

It is said that good things take time ....and patience ....and so it is proving to be.

The main focus for BRCT throughout the year has again been the wind cluster. This project, like all major projects, is complex and full of both predictable and unpredictable challenges. Slowly, almost all of those challenges have or are being met and the year ahead promises to be one where we will be able to proceed with much greater speed and confidence.

Major achievements this year include the collection of wind data from the 30 metre tower on Porteous Hill. As of April 2014 we have 12 months of excellent data from the 30 metre tower and almost 3 years data from the 10 metre tower. This data will be expertly analysed to provide a detailed analysis of the wind available which can then be used to identify the most appropriate turbine models for our conditions.



That will then provide the basis for the business plan. The business plan will set out the opportunity (how much wind therefore how much income), the risk profile (identifying what could go wrong, what needs to be guarded against), and present a plan for securing the necessary investment to develop the wind cluster. A resource consent application has been largely prepared. BEL (Blueskin Energy Limited, a wholly owned BRCT company) has also been set up as the main development vehicle. BRCT established BEL as a legal entity to enter into negotiations with appropriate parties whether they be landholders or potential purchasers of the power generated. This company will be required to raise the capital for the wind cluster assuming the business plan continues to make financial sense.

There are still many challenges ahead, but we anticipate that in the next year a fully rounded proposal and business plan can be brought back to Blueskin communities.

From small things large things grow. That's another truism that has been validated in the last year.

The insulation scheme undertaken by BRCT in the Blueskin area in 2009 created valuable knowledge and experience. That knowledge and experience led to contracts from the University of Otago and Presbyterian Support that involved BRCT in delivering Community Energy workshops and/or Home Performance Assessments in Pine Hill, North East Valley, Blueskin and Brockville.

On the back of that a citywide programme has now been launched.

The Otago Community Trust, the DCC and Presbyterian Support all contributed resources and assistance to allow BRCT to run a Cosy Homes Symposium – an event that kick started the Cosy Homes initiative. It brought together a range of organisations who had been working is isolation, but with the same objective. Seventy-six stakeholder agreed on the vision that "Every Dunedin home is warm and cosy

by 2025". BRCT now sits on the governance group, with other city stakeholders.

BRCT is also contracted by the Cosy Homes Governance group to drive the initiative forward. In parallel, as part of our support of Cosy Homes and our work on fuel poverty we organised a 'Cosy Homes Flash Mob' earlier this year, and have recently participated in a bid by Ellis Fibre to provide targeted marketing for free insulation retrofits to vulnerable households. We have found that our expertise and skill, developed through practical, on-the-ground work, is in demand from other agencies and businesses attracted to the Cosy Homes vision. The job isn't finished in the Blueskin area but our experience to date has created a template for many more cosy homes... in one sense we are 'Blueskinning' the City.

Does that mean we've finished the job in Blueskin? No, there is plenty more to do and the Cosy Homes initiative should help those still in urgent need of support.



Does that mean we are losing our Blueskin focus? I think not. If we can illustrate to others how things might be done better and assist them in doing so, we are providing a service not just to our communities but to our region and ultimately to our country in terms of creating strong, resilient communities and initiating meaningful change.

The number of photovoltaic cells on houses in the Blueskin area has substantially increased over the last six months. No, we're not directly responsible for that development, but we do see ourselves as a catalyst that helped to bring about that development and we continue to receive and respond to regular solar enquiries.



That catalytic activity is also seen in submissions made to the DCC during the year. We're pleased to see the DCC picking up on ideas like Cosy Homes, considering energy matters in general through its Energy Plan, involving us in on Climate Change work (we worked with the DCC on Community led climate change planning for Waitati), exploring local food resilience and giving serious consideration to low carbon transport options like charging stations for electric cars within the city.

We are currently recipients of a Lotteries Research Grant to complete a 'Blueskin Food System Assessment' with Ahika Consulting, which will include recommendations on building a more resilient local food system, one of the key action areas identified by local residents in our Climate Change work.

The Cuppa Tea Blog has continued to stimulate discussion around matters that are of particular interest to us over the last year. Like many such blogs it takes time for it to gather momentum and readership. We trust it will continue to develop over the next twelve months.

Many individuals have assisted BRCT throughout the year and deserve specific mention, particularly: Laurence Hay, Tom Clark, Gerry Thompson, Murray Soal, Jenna Packer, Peter Goodin, Stephen Chiles, Kath Dixon, Robin Mitchell and Chris Freear.

We stay afloat because of the support and generosity of a number of organisations. We need to particularly thank our partner, the Akina Foundation (formally Hikurangi), whose financial support, brokerage and advice continues to be invaluable. Other organisations who have been exceptionally supportive include: the Otago Community Trust, the Lottery Grants Board, WindFlow Technology, DNV-GL Energy, Russell McVeagh, the University of Otago, Fulton Hogan, Pioneer Generation, Lucas Associates, Combined Rural Traders, Bendigo Valley Trust, Enasolar, SolarCity, the NZ Wind Energy Association, Craigs Investment Partners for our meeting venue at the start of the year and of course the Blueskin Library who provide us with a greatly valued monthly meeting space.

Two trustees are standing down at this time: Katie Parker and Tony Wilson. Their contribution to the Trust over a number of years has been considerable and I need to thank them both on behalf of BRCT and the communities we serve.

Our staff Scott Willis and Niki Bould have again served us exceptionally well. We're blessed with two highly qualified and dedicated individuals who on a weekly basis have to deal with numerous challenging projects, often breaking new ground and always having to

overcome the challenging and difficult with little money and very limited resources. We might say that they have made multitasking an art form.

The future resilience and viability of our communities remains our primary objective and we believe we are well placed to advance that objective in the next twelve months. But it is also rewarding to see that the work done in this small corner of the country is making waves elsewhere.

BRCT's flagship project is the community wind development through Blueskin Energy Ltd (BEL). BEL is BRCT's emerging social business. Energy, more broadly through our 'Social & Environmental Good' activity, is something we know well and where we invest time and resources for public good and where further social business opportunity is emerging. Climate Change Planning is our second major project area, and alongside this work we continue to strengthen our position through good systems, staff and resources. BRCT, as a social enterprise, is creating a realignment of economic activity around social wellbeing while reducing environmental risks and ecological scarcities. We have a role we relish as an 'enabler' in the Blueskin community.

# 5. BRCT: Social Enterprise

The 2013-14 Annual Plan's five objectives were:

- Blueskin wind cluster
- Climate Change Planning
- Effective Advocacy
- Economic Power
- Social and Environmental Good.

BRCT has been working hard on developing commercial strategies to deliver further community and environmental benefit over the past year. In December 2013 BRCT established Blueskin Energy Ltd, a new, wholly owned BRCT company to develop the wind cluster. BEL has since secured a seedling loan and is working on an investment proposition to fund the wind development. BRCT has also been valuing its skill and knowledge base and has secured contract funding to develop the Cosy Homes initiative whose vision is "Every Dunedin home will be warm and cosy by 2025". Aligning with our objective to grow our delivery of social and environmental good, particularly via energy actions, BRCT has additionally developed a Home Performance Advice service, contracting two nationally certified Home Performance Advisors. At the time of writing, BRCT is also negotiating a partnership with Ellis Fibre to provide targeted marketing, assessment and audit for free insulation retrofits to vulnerable households, as part of an EECA Warm Up NZ contract. Finally, BRCT has confirmed with City Forests that timber from the Silverpeaks Forest can be made available to the Trust for a wood business to be developed through 2014.

Trustees have remained committed to ensuring the Trust develops greater economic autonomy in order to pursue clear community objectives and initiatives effectively. BRCT's values (*Thriving together well and equitably*; *Distributing surplus to enrich social & environmental health*; *Encountering others in ways that support their wellbeing as well as ours*; *Living and consuming sustainably in recognition that all human life and activity occurs within the limitations of planet Earth*; *Caring for - maintaining, replenishing, and growing - our natural and cultural commons*; *Investing our wealth in future generations so that they can live well*) continue to inform the development of our social enterprise activity and our work on low carbon economic development.

# 6. Our Funders, Donations and Pro Bono Support

### 7. Accounts

### 7.1. Treasurer's Report, Financial Year ending 31 March 2014.

I am pleased to enclose the Trust's Financial Report for the Year ended 31 March 2014.

The Trust has achieved an operating surplus of \$2,840 in the 12 months to 31 March 2014. It also received \$51,000 worth of donated energy generation equipment, enabling it to increase its net assets to \$74,169. At its balance date, the Trust had built its cash reserves to \$91,500, although this was assisted by a \$15,000 loan from the Hikurangi Foundation (renamed the Akina Foundation) and by \$55,000 of income received in advance from the Lotteries Grants Board. These cash advances will be drawn on in the 2014/2015 financial year but provide the Trust with sufficient liquidity to meet its immediate needs. The financial statements accompanying this annual report are presented as interim pending auditor clarification of the treatment of two transactions.

In 2013/2014 the Trust continued to broaden its sources of revenue, which included grants from a range of funding agencies (including the Lottery Grants Board, Dunedin City Council (DCC), Otago Community Trust and Presbyterian Support Otago) and a significant level of gifts and donations from members of the Blueskin community and nationally who are supportive of the Trust's work and wish to assist it. The Trust is also exploring developing social businesses to further broaden its revenue base.

The Trust has also been able to secure a large amount of pro-bono support from prominent national firms including Russel McVeagh, Foot Law and DNV-GL Energy, and enjoys a durable partnership with the Hikurangi Foundation who provided the Trust with a \$15,000 loan in 2013/14. While the value of the pro bono support does not appear in the Trust's financial statements, it has greatly assisted the Trust to continue its work.

The Trust continues to build strong relationships with key local stakeholders including the DCC, the University of Otago and Pioneer Generation. City Forests are also now working with the Trust to help secure the success of the Blueskin Energy Project.

In 2013/14, the Trust was also able to support the work of local volunteers through reimbursing them for out of pocket expenses they incurred whilst working for the Blueskin community. These included volunteer costs associated with: the Cosy Homes Flash Mob; the Waitati Film Society; the Waitati Free Shop; the Long Beach Hall Committee; the Purakaunui Amenities Society; Karitane School volunteers, the Pioneer Hall Society, and; BRCT volunteers.

As noted in last year's report, the Trust will require substantial income in the next three years so that the Blueskin Energy Project can be brought to fruition. The support of the Lottery Grant Board for a further 2 year period (including the 2014-15 year) will help provide the Trust with a sound financial base to continue the development of the Blueskin Energy Project as well as other initiatives aimed at building resilient local communities.

Finally, my thanks go to Niki Bould for her excellent work in maintaining the Trust's financial systems throughout the year.
